

VSO Funding Application Process

OVERVIEW

Volunteering Victoria recently secured \$300K of state funding to support Volunteer Support Organisations (VSOs) through COVID-19. The conditions of this funding are that:

Volunteering Victoria will identify 12 Volunteer Support Organisations to provide targeted practical assistance with engaging volunteers, in the context of COVID-19.

Successful VSOs will be provided with \$25K in funding to be used over a six month period to achieve the State Government's objective.

It is important to note that this funding is not designed to support business as usual activities and/or current daily activities already in place to support volunteers locally during COVID-19. As a result, we are requesting that organisations wishing to participate identify their number one local COVID priority and detail how they will address this within the scope of the \$25K funding available.

SELECTION PROCESS

To ensure transparency and accountability in the application selection process Volunteering Victoria has convened a judging panel to include Anthony Carbines MP together with representatives from DHHS and Volunteering Victoria. The panel will assess applicants' eligibility based on the selection criteria and weighting scale proposed below.

Additional scoring is also available for collaborative applications submitted by more than one VSO and where outcomes support the engagement of CALD communities and/or people with disability

TIMEFRAME

Applications are open from 7 September 2020 and <u>will close on 20 September 2020</u>. Successful applicants will be notified by 30 September 2020.

Funding will be distributed to successful VSOs on 1 October 2020. Projects are to conclude with submission of final report and recommendations by 30 April 2021.

VSO Funding Application Process

Scoring of VSO funding applications will be completed by a judging panel using the following metrics. The 12 applications with the highest overall score will be selected to receive the state funding available.

	According to the information provided in the application please evaluate the expected outcomes in line with the project objective giving them a score according with the scale provided below.
	Outcomes are clearly defined and show strong links to supporting volunteer engagement through COVID-19.
Good 11-20	Outcomes are clearly defined and show some links to supporting volunteer engagement through COVID-19.
Poor 0-10	Minimal outcomes defined for supporting volunteer engagement through COVID-19.

Criteria 3 20%	Engagement of Community Activation and Social Isolation (CASI) community connectors.
	According to the information provided in the application please evaluate the level of engagement of CASI community connectors in line with project outcomes giving it a score according with the scale provided below.
	NB. Engagement with CASI community connectors ensures that volunteer engagement initiatives are directly supporting the needs of local communities through COVID. For more information on CASI please visit https://www.dhhs.vic.gov.au/community-services-all-sector-coronavirus-covid-19 .
Exceptional 21-30	Engagement of community connectors directly supports the achievement of one or more expected outcomes.
Good 11-20	Engagement of community connectors shows some influence for supporting the achievement of one or more expected outcomes.
Poor 0-10	Engagement of community connectors shows minimal influence for supporting the achievement of one or more expected outcomes; or there is no evidence of proposed engagement.
